# LENNY HALL

**Leonard (“Lenny”) Hall** is a seasoned security professional and Vice President of Threat Assessment Management Services for OSS. During the eighteen years prior to joining OSS, he was the Security Operations Director & Chief Security Officer (CSO) for Scotts Miracle-Gro, a Fortune 500 company.

The primary focus of Lenny’s career has been related to threat assessment management, executive protection, critical infrastructure protection, and homeland security compliance. As a security professional, he has continued his lifelong pursuit of knowledge and training in these subject matters of expertise.
